Stabilized Rice Bran: Rice bran is a by-product of the rice milling process (the conversion of brown rice to white rice), and it contains over 200 antioxidants, phytosterols and phytochemicals that impart supportive effects on human health. Bran is particularly rich in dietary fiber and fatty acids and contains significant quantities of starch, protein (balanced amino acid profile), vitamins (rich in B complex), and dietary minerals. Sunflower Lecithin is a nutrient molecule active in normal biochemistry of cholesterol, liver function and handling of toxins. Aloe Leaf Powder: Aloe vera is a desert lily that its leaf gel has been used by humankind to support health for over 5,000 years. Aloe vera has been used for eons in traditional, folk and herbal medicine. Aloe is most commonly used to support normal health of the largest organ in the human body, the skin. It has been long used internally to support normal metabolism of the gastro-intestinal tract, blood glucose levels and liver health. The plant makes complex oligosaccharides used to nutritionally support cellular synthesis of bio-active compounds that support normal host defense, repair, regeneration, balance and function in multiple organ systems. An extensive supply of these phytonutrients for support of normal cellular metabolism, using the key acetylated mannose (acemannan), has resulted in synergism or a more robust response when consumed with other plant nutrients.



Cysteine: Cysteine, more abundant in cruciferous vegetables, is assembled inside cells using glycine and glutamic acid, all amino acids found in food, to make the body's most active intracellular free radical scavenger. This normal biochemical process is under innate gene control and contributes significantly to a normal state of good health. The American diet is commonly low in Cruciferous vegetables.



Inositol Hexaphosphate (IP6): IP-6 is a nutrient active in the normal nutrition and thus biochemistry of lipids in the human body (cholesterol, hormones and fatty acids) IP 6 is active in the normal management, i.e biochemistry, of liver, free radical quenching compounds, immune system function, cellular division and growth of cells.



Dioscorea (yam) powder: Dioscorea is a complex phytonutrient utilized by the body in normal hormonal synthesis and management of this complex system of innate endocrine balance and control. The benefits to human health observed for decades in this nutrient molecule's use, has not been fully determined by modern science. Research indicates the plant steroids support more natural i.e., normal hormone balance in males and females.

Extensive animal studies indicate this nutrient molecule is active in the normal control of blood sugar levels in animals and humans. Original folk medicine usage has been confirmed that this complex nutrient molecule is active in normal control mechanisms of reproduction, menstrual periods, hormone synthesis, inflammation and function of joints and tendons.



Citric Acid: Citric acid bonds easily to minerals and metals, called *chelation*. UltraTerra Calcium Silicate: This natural rock formation has been extensively researched at Texas A&M University, MD Anderson Clinical Center and the CDC. Why Hemp Seed Powder?

Since 2009 when Wellness Quest first offered **NEW EDEN**, I have searched the literature and coordinated this source of knowledge with our field of users by adding additional ingredients to the key component acetylated mannose of aloe leaf gel origin.

One also looks for additional nutritional sources that are different plants and in so doing one finds nutrients that are not in the existing formula because the plant genes differ for each plant. Therefore, each plant supplies additional nutrients. One seeks a seed or plant part that has a very broad scientific data base of benefits and hemp is very broad in its coverage of deviations from the zone of normal health.

OVER RIDING REASON FOR THE INCLUSION OF HEMP SEED:

The political aspects of changing the federal law carried immense weight in this decision among all the seeds that could have been chosen. This is due to the federal law this hemp industry was able to change radically. For decades hemp seed that would germinate were forbidden to be imported into the USA. They changed this law.

There are at least 10 monosaccharides (sugars) in the cell wall of each plant and the % of each combined with phytochemicals and phytonutrients and the chemical arrangement of its molecules determines; do we eat it raw; do we have to cook it to eat it, do we build things with it or do we burn it for heat. Each plant not only has these properties, but its seeds food supply for the sleeping embryo and the cotyledons has a nutrient store to allow the germinated embryo to grow the first root and leaf and then photosynthesis is initiated to establish a self-sufficient and independent plant.
